## Stormwater Refunds

## **Alley Naming**

- The Committee has reviewed and recommends to Council numerous alleyway names currently
  without proper signage. The request to advertise an Ordinance will come before the Council
  once Franklin County GIS representatives ensure the uniqueness of each alley name compared
  to other Franklin County municipalities. Essentially, the County prefers no two alleys to share a
  name throughout Franklin County.
  - UPDATE: Franklin County representatives have reviewed the Public Facilities
     Committee's list of proposed alley names and has identified duplications. As a result,
     Borough staff will need to work with the Public Facilities Committee at the August 19<sup>th</sup> meeting to propose different names.

## **CDBG Handicap Ramp Installation**

• Approved for bidding in March 2020, CDBG grant handicap ramp construction will commence, upon approval of the Borough Council, in August 2020. The first round of bid opening will be for ramps along Route 16 needed to be improved for ADA compliance, along with the installation of two new ramp locations. Ramp installation on Rt. 16 is in advance of the PennDOT resurfacing project, which is postponed until 2021. After an awareness of cost estimates from bid proposals compared to remaining funds from the CDBG grant, the second round of bidding will be advertised. Ramps to be included are those on Williamson Avenue, Sunburst Drive, Lietersburg Street, Mifflin Lane, Tyrone Street and Walter Avenue. CDBG requirements state that the Borough must have the project completed by October 2020. The total available grant funding, with no matching requirement, is \$178,361.00.

### **Pension Awareness**

• In response to questions and concerns regarding the Borough of Greencastle's pension plan, the Borough has provided a few informational documents for public review. The documents outline the pension benefit, calculations and other pertinent facts, which were asked to the Borough Council last fall. The documents will be available on our website and hard copies can be obtained at the Borough office for \$0.25/page.

## **Conrad Update**

 Borough staff has been in contact with a contractor to abate the remaining nuisances declared in the Court Order dated February 21, 2020. Once the quote for removal has been finalized, the Borough Council will consider the approval of the expense. Associated expenditures are unbudgeted however, will be passed to the property owner through municipal lien.

### **Public Safety**

Upon citizen request and Borough staff employee sight visits, the Public Safety Committee
recommends to place stop signs at the intersection of Elm Lane and Spruce Lane. The existing
buildings create sight distance hardships and without stopping mechanisms in place, two
vehicles could collide. Placing stop signs at the intersection will slow traffic and reduce risk of an
accident.







#### **Public Works**

### **Project Updates**

 With heavy rainstorms bringing much needed rainfall, the Borough Public Works team has been busy with street sweeping and inlet cleaning. The Borough has approximate 400 inlets and thousands of linear feet of stormwater pipe. Inspections, repairs and routine maintenance to stormwater infrastructure help to reduce flooding on borough streets and alleyways.

## **Project Updates**

- As we prepare to reconstruct North Carlisle St in 2021, Kevin has directed USG to inspect sewer Borough owned sewer laterals. USG discovered a few laterals showing significant damage, to which the Borough Public Works team has begun to replace. At times, sections of North Carlisle Street may be closed in order to make repairs.
- The Carlisle Street Pumping Station has been advertised for bidding and a pre-bid meeting was held on July 21, 2020. Bid opening is scheduled for August 4, 2020 at 1:00pm in Borough Hall. The reconstruction of the pumping station is a 2020 approved capital expenditure with an estimated total cost of \$345,000.00. Cost estimates include engineering and construction.
