

## **ORDINANCE 2018-01**

AN ORDINANCE OF THE BOROUGH OF GREENCASTLE, FRANKLIN COUNTY, PENNSYLVANIA AMENDING CHAPTER 190 OF THE CODE OF THE BOROUGH OF GREENCASTLE, ENTITLED "VEHICLES AND TRAFFIC", TO PROHIBIT STOPPING, STANDING AND PARKING ALONG PORTIONS OF SOUTH RIDGE AVENUE DURING CERTAIN HOURS AND TO ESTABLISH A LOADING ZONING ALONG WEST BALTIMORE STREET.

WHEREAS, the Borough of Greencastle (hereinafter the "Borough") is authorized to regulate the parking of vehicles along sidewalks pursuant to Section 1202(13) of the borough Code, 8 Pa.C.S. § 1202(13), and to regulate parking and provide parking accommodations to promote the convenience and protection of the public pursuant to Section 1202(31) of the borough Code; and

WHEREAS, the Borough desires to prohibit stopping, standing, and parking along a portion of Ridge Avenue during certain hours; and

WHEREAS, the Council of the Borough of Greencastle deems it in the best interest and for the general welfare of the citizens and residents of the Borough to amend certain provisions of Chapter 190 of the Code of the Borough of Greencastle.

NOW THEREFORE, BE IT ENACTED AND ORDAINED by the Mayor and Borough Council of the Borough of Greencastle, Franklin County, Pennsylvania, and it is enacted and ordained as follows:

**SECTION I**: Chapter 190 of the Code of the Borough of Greencastle, entitled "Vehicles and Traffic", Article III, entitled "General Parking Regulations", Section 190-28 shall be retitled "Parking, stopping, or standing prohibited at certain times on certain streets and alleys" and a subsection C shall be added providing as follows:

C. Parking, stopping, and standing are hereby prohibited on the following streets and alleys of the Borough at any and all times between the hours included:

Street	Side	Between	Days	Hours

**SECTION II:** Chapter 190 of the Code of the Borough of Greencastle, entitled "Vehicles and Traffic", Article III, entitled "General Parking Regulations", Section 190-24 shall be amended by placing the current contents thereof into a subsection A, then adding a subsection B that includes the following:

B. The following are hereby established as loading and unloading zones, and no vehicle shall be parked there at any time, except for the purpose of loading or unloading such vehicle:

Location: On W. Baltimore Street, a distance beginning 170 feet from the face of curb from the intersection of W. Baltimore Street and N. Carlisle Street, extending 190 feet.

- **SECTION III**: **REPEALER.** All provisions of previous Ordinances of the Borough of Greencastle which are contrary to this ordinance are expressly repealed.
- **SECTION IV: SAVINGS CLAUSE.** In all other respects, Chapter 190 of the code of the Borough of Greencastle shall remain as previously enacted and ordained.
- <u>SECTION V</u>: SEVERABILITY. The provisions of this Ordinance are severable and if any of its sections, clauses, or sentences shall be held illegal, invalid, or unconstitutional, such provisions shall not affect or impair any of the remaining sections, clauses or sentences.

**SECTION VI: EFFECTIVE DATE.** This ordinance shall take effect immediately.
