

Regular Meeting, Council Hall,
October 2, 1933; 7:30 P. M.

The regular October meeting of Council was held on the above date with the following present:-

Burgess, D. W. Shinham, Pres. W. Earl Gardner, and Councilmen, Hoachlander, Stover, Bryson, Leshner and Frank.

Minutes of the preceeding meeting were read by the secretary and approved without correction.

Borough Treasure Chas. W. Bert, Jr. reported as follows:-

The secretary reported receipts totaling \$ 3229.49, of which \$ 1000.00 represented check from County Commissioners for work on St. Thomas Road; \$ 227.61 water rents; and the balance from misc'l. sources. On motion both of the above reports were approved and accepted.

Police Chief, Ambrose reported nine arrests during the month of September and turned in fines totaling \$ 27.00.

Water Manager Bert asked that a refund of \$ 2.85 be granted Mrs. Mary Fisher. On motion this request was approved.

Mr. David Walters appeared before Council and explained that he proposed to build a dwelling on S. Carlisle St. extended, just outside of the borough limits. He asked if possible that the borough limits be extended so as to include this property. President Gardner promised further consideration of the matter.

A committee from the Rescue Hose Company represented by Mr. Marvin Gonso and Charles Holbert, explained that the rubber boots used by the fire company were in an unservicable condition and asked that 12 pairs be purchased for them. Several samples of different quality were submitted. After some discussion, it was moved and passed that the Fire committee be authorized to purchase 6 pairs of boots of the re-inforced type.

A return of a check to the amount of \$ 45.00 to Mr. Harry Conner, Chambersburg Ice Dealer, was ordered by a motion made by Mr. Gardner and seconded by Mr. Stover. It was stated that because of question of the legality of the ordinance under which this was collected, and the fact that it had not been collected from other dealers, that this amount should not be accepted.

Meeting of Oct. 2, 1933 continued.

The following resolution was introduced by President Gardner:-

Resolved by the Burgess and Town Council of the Borough of Greencastle that the Unoccupied building upon the lot known as the "Old Moore Property" situate on the north side of West Baltimore Street in the Borough of Greencastle, has become a nuisance and a fire hazard dangerous to surrounding property, and that the Burgess be authorized to take all legal steps necessary to abate and remove said nuisance.

The resolution was seconded by Mr. Stover and unanimously adopted.

A resolution requiring that sidewalks be laid on the West side was presented by Pres. Gardner, seconded by Mr. Stover and after discussion, adopted. (For text see ordinance book)

On motion President Gardner was authorized to represent the borough in proceedings for the reduction of coal rates to this vicinity.


