Regular Meeting, Council Hall, December 4th, 1933, 7:00 P. M.

The regular December meeting of Council was held on the above date with the following present: Pres. W. Earl Gardner, Burgess D. W. Shinham, Councilman, Stover, Hoachlander, Lesher, Bryson and Frank.

Minutes of the last regular meeting and one special meeting were read by the secretary and approved without correction.

Treasurer, Chas. W. Bert, Jr. reported as follows: -

On motion both the above reports were approved and accepted.

Police Chief, Ambrose, reported six arrests for the month.

Mr. M. L. Propst appeared before council and presented a petition bearing 211 signers asking that council take some action toward having the Greencastle L. H. F. & P. Company repair its lines and equipment in order to eliminate the

noise and intereference which it is causing in local radios. The secretary was instructed to write Mr. F. W. Harris, president of the company and acquaint him with the facts in the case and ask that immediate steps be taken to eliminate this condition.

Mr. Harry Miller asked that council permit him to store manure on his premises or at least give him explicit directions on the matter Pres. Gardner explained that this matter was in the hands of the Board of Health and that council could take no action.

Mrssers Rife and Stephey explained to Council that a new high tension line is in progress of erection by the South Penn Power Company and explained the desirability of having the location of this line moved outside of the borough limits when it is reconstructed. Pres. Gardner promised to take the matter up with the borough attorney to determine the borough's rights in this matter.

Mr. Hoachlander of the Street committee stated that in order to keep local unemployed at work it was necessary to start some work projects immediately. It was stated that work on the new school-building could not start for at least a week or more and that work must be provided immediately. After discussion it was decided on motion that 71 men should be put to work to-morrow morning (Dec. 5th) approximately half of the number to be sent to the reservoir to grade and rebuild the borough's right- of way there, while the other half be employed to grade and re-build S. Madison Street from Carl Avenue to Carlisle Street. On motion the street committee was authorized to hire all necessary trucks, secure necessary stone, goggles and othe equipment necessary. Large stone broken in place by hand was specified as the type of roadway. A waterbound macadam to be made and oiled later.

On motion, water manager Bert, was instructed to immediately get prices on four and six inch cast iron water pipe, and also obtain price of hauling same by truck.

The water committee was authorized by motion to connect if necessary to furnish employment a number of "dead ends" in the water system using approximately 790 feet of pipe.

It was moved, seconded and passed that the street committee be authorized to close Madison Street while same was under construction, also to furnish all necessary tools etc. It was decided, however that all men must furnish at least a pick or shovel for their own use.

Mr. B. H. Daley, tax collector asked that exemptions for the collection of taxes be granted him as follows:- 1930 taxes totaling \$ 53.79; 1931.taxes totaling \$ 136.64. The five percent penalty in both above cases also to be exempted.

Mr. Daley also explained that it would be necessary to file leins for 1930 taxes on or before Dec. 15th next, and on motion the secretary was instructed to have such a list prepared and entered according to law.

No action was taken on a request from Mr. Samuel Hicks that an alley be opened in the vicinity of his new property on East Madison Street,
