

Regular Meeting, Council Hall,
July 2, 1934; 8:00 P. M.

The regular July meeting of Council was held in Council Hall on the above date.

Present: President, W. Earl Gardner; Councilmen, Stover, Walck, Davison & Gilland.

Minutes of the last regular meeting were read by the secretary and approved without correction.

Borough Treas Bert reported as follows:-

Police report: Police Chief Ambrose reported six arrests for the past month, with \$ 35.00 in fines collected.

On motion, the above three reports were approved.

A committee from the Rescue Hose Company appeared before Council and stated that they had tested the company's hose with a pressure up to 250 lbs. per sq. inch. The result was as follows:-

1650 ft. withstood this pressure without leaks.

200 ft. leaked slightly, but would be of service at less pressure. About 600 feet of addition hose was available which would withstand city water pressure. The committee asked that some additional hose be purchased, so as to allow good hose to be in service while other was on drying rack. The matter was dis-

cussed, but no action taken.

Relative to the 33,000 volt line of the South Penn Power Co. the secretary reported that Attorney Hoke had advised him that under the terms given the C. G. & W. St. Ry. Co. for the abandonment of their tracks, that a right was granted for the use and maintenance of this line, and that in his opinion, Council had no right to order it removed. He stated, however, that if it were shown to be a hazzard in case of fire, that it was possible the Public Service Commission would order its removal. He promised to investigate this angle and report later. Also to attempt to effect an amicable agreement for its removal.

Water Manager Bert, stated that on account of the dry weather, it was desirable to inform the water consumers of the conditions under which the hose may be used. He read a copy of a notice to consumers and asked that the same be published in the newspaper. On motion of Dr. Gilland, seconded by Mr. Stover, he was ordered to publish the notice in the Echo-Pilot; to have hand bills of the same printed and distributed over the town; and to secure an additional supply of hand-bills to be distributed at the time of mailing the next flat-rate bills.

The matter of providing a closet or other place in which to place the borough maps and records was discussed. On motion, the secretary was instructed to have such a closet or case built, to be of such size, design and location as he saw fit.
