Regular Meeting, Council Hall, Dec. 3, 1934, 7:00 P. M.

The regular December meeting of Council was held on the above date with the following present:-

President, L. R. Walck; and councilmen, Davison, Stover, Gilland, Hoachlander, Friedly.

Minutes of the last regular meeting and two special meetings were read and approved without correction.

Treasurer, Chas. W. Bert, Jr. reported as follows:-

Police Chief. Ambrose, reported six arrests for the month of November, resulting in the collection of \$ 19.95 in fines.

Stephen Tenley reported that he had inspected about half of the town for water leaks, and had found 132 leaks.

On motion, the above reports were approved and accepted.

A committee of Antrimtownship residents were present and heard a report of the fire department. The fire department estimated that the average upkeep for the department over a period of six years was approximately \$850.00 per year. Records showed that in the last period of 18 months that 15 alarms had been answered in town, and 20 in the country. For the same period apparatus traveled 129 miles to country fires; and 24 miles to town fires. The committee was requested to insist that the Township supervisors contribute \$400.00 annually toward the support of the fire company.

The matter of the purchase of additional hose was discussed. On motion Mr. Hoachlander, seconded by Dr. Gilland, the Fire and Water committee was authorized to purchase 300 feet. of 1 1/2 in. hose with necessary nozzles & fittings in addition to the 2 1/2 in hose authorized at a former meeting.

On motion Dr. Gilland, seconded by Mr. Friedly, the motion passed at a previous meeting to purchase a tract of land from Mrs. Wm. R. Davison was reconsidered, and further action post-poned until a later date.

A revised ordinance granting the right for the Gettysburg Gas Corporation to install service within the borough was presented. Except for a few slight changes, the ordinance was the same as that passed at a previous meeting. On motion of Dr. Gilland, seconded by Mr. Stover, the ordinance passed at the Nov. 21st. meeting was rescinded. And on motion Mr. Stover, seconded by Mr. Hoachlander, the new ordinance was unanimousely passed.

The Light Committee reported that they were negotiating with the G. L. F. & P. Company for the installation of a whiteway lamp on center square to replace the traffic signal at that point/

On motion Mr. Stover, seconded by Mr. Hoachlander, Mr. Chas. W. Bert, Jr. was designated Water Superintendent, with all the authority that is by law and ordinance granted to that office. The same motion fixed the salary for this office at \$50.00 per month.

On motion Mr. Stover, seconded by Dr. Gilland, the sum of \$45.00 was ordered paid to Mr. Bert to reimburse him for unusual expenses incident to the pumping operations and other improvements to the water system carried on during the past few months.

The Streett committee was also authorized by motion to repair and oil and chip Spring Grove Avenue, also to have the motor of the town road roller overhauled and repaired.
